
2.0 POSITION CONTEXT & OBJECTIVE(S):

Hatches Ltd in partnership with Agricultural Business Initiative (aBi) and other partners is implementing a project titled "Increasing Market Access and Productivity of the Poultry Value Chain through effective and environmentally efficient Inputs in Central and Eastern Uganda".

The project objectives are: i. Provision of high-quality Day-old chicks to both model farmers and open market poultry farmers ii. Promote the use of Black Soldier Flies (BSF) as an alternative to traditional protein sources for quality poultry feeds at fair and stable prices iii. Establish sustainable market linkage options for farmers with off takers and to iv. Enhance farmer knowledge on modern poultry farming through training and demonstration.

Under the overall guidance of the Chief Executive Officer, Company Manager, Project manager and direct supervision of BSF Project Expert, the entomologist is responsible of assisting the company in field activity planning, maintenance of black soldier fly colonies design and implementation of entomological experiments, Supervising BSF Field Extension Workers team and Train and work closely with the community. He is therefore expected to have excellent attention to details, good leadership and Management skills, communication and capacity building skills.

The Entomologist will ensure high quality production and observation of bio-security measures, standards of Hatches Itd and timely outputs in a cost-effective manner. He/She works in close collaboration with Projects Manager, Extension Workers, communities and partner teams specially to provide technical guidance and management support as well as an honest and fair



collaboration to M&E and Auditors.

3.2. Duties and Responsibilities

The Entomologist will have the following duties and responsibilities:

3.2.1 Insectary management

- Rear and maintain the black soldier fly colony
- Source insect feed and materials for their activities
- Measure key insect performance indicators
- Follow and adhere to Hatches Itd and its partner guidance and strictly observe biosecurity
- Keep a clean and well-organised workspace
- Assist in the organisation of planned activities, trials and procurement of materials required for their execution
- Providing technical and professional support to insectary workers
- Designing research/ experiments/technology geared towards improving insect productivity
- Producing technical reports on activities undertaken
- Working towards improving insect performance in terms of growth and survival
- Identifying the feed resources and developing feed formula for insects
- Conduct quality assessment and quality optimization of the BSF products such as the wet and dry larvae, frass, oil and any other value-added products

3.2.2. Leadership and Management

- Ensure that the BSF extension worker team is aware of the schedule and job expectations on a daily basis
- Involve the BSF extension worker team in regular meetings to communicate information intended for them
- Ensure communication to the BSF extension worker team on any changes in policies/ processes by the company through required verbal/ written mechanisms
- Ensure participation of the BSF extension worker team in various engagement initiatives



organized by the company

- Counsel and address issues among the team for any work-related issues
- Support in deployment of the BSF extension worker team as per production schedule and the organizational norms and guidelines
- Ensure periodic training of the BSF extension worker team and support the team by delivering trainings especially in the field of latest, BSF production, machinery and equipment
- Share knowledge of processes, techniques and products with the team to enhance their skill levels
- Provide feedback to the manager pertaining to performance of the team
- Assist with data collection and keep detailed and well-organised records
- Assist with literature research and administrative activities
- Ensure that the accommodation/rearing area for the birds is well maintained and not prone to diseases such as bird flu
- Ensure that materials and supplies are replenished as and when required
- Comply with waste disposal regulations
- Check the requirements of different resources like chicks, feed, equipments, water, litter material etc.
- Plan and participate in community training activities

3.3. Measurable Outputs and Performance Indicators

- Preparation of weekly, monthly and activity reports;
- Assist the Project Manager in preparing other relevant reports concerning his farm;
